ARTICLES OF INCORPORATION

These Articles of Incorporation are signed by the incorporators for the purpose of forming a non-profit corporation pursuant to the provisions of Act 327, Public Acts of 1931, as amended, and Act 284, Public Acts of 1972, as amended, as follows:

ARTICLE I.

ARTICLE II.

The purpose or purposes for which the corporation is organized are as follows:

1. To promote and actively engage in the health, welfare and care of the subdivisions known as Strawberry Hill Estates I, II, III and IV.
2. To maintain, manage, own and/or operate parks and recreational areas for the benefit of the property owners in the aforesaid Subdivisions.
3. To enforce the building and use restrictions of record for the aforesaid subdivisions.
4. To assess property owners dues and assessments, if required, to carry out any corporate purposes hereinabove set forth.

1. This form is issued under the authority of Act 284, P.A. of 1972, as amended, and Act 162, P.A. of 1982. The certificate of change of registered office and/or change of resident agent cannot be filed until this form, or a comparable document, is submitted.
2. Submit one original copy of this document. Upon filing, a microfilm copy will be prepared for the records of the Corporation and Securities Bureau. The original copy will be returned to the address appearing in the box above as evidence of filing.
Since this document must be microfilmed, it is important that the filing be legible. Documents with poor black and white contrast, or otherwise illegible, will be rejected.
3. This document is to be used pursuant to section 242 of the Act by domestic and foreign, profit and nonprofit, corporations for the purpose of changing their registered office or resident agent, or both.
