#### **Old Business**

- Done Roads: Corinne discussed with the Pat Hohl, Hamburg Township Supervisor. Road maintenance to be performed in the neighborhood by Labor day, otherwise Corinne to notify Pat Hohl
- Pending Roads: Dave to contact Dennis at the County Road Commission
- Pending Communication: Dave to finalize the April 30<sup>th</sup> HOA 2019 Annual Meeting Minutes for posting to the website
- Pending Dogs: Corinne to coordinate with the Bluffs and draft a memo to all residents about leash laws and Park Rules

#### **New Business**

**Report from the JAC meeting** – Larry reviewed major items from the JAC meeting minutes of 6/2/19. Edits to the JAC By-Laws and the JAC Pontoon Drawing Rules are on-going. Corinne to offer Bill Armour a role as the fourth SHEHA representative to the JAC.

**JAC Seawall project** - Corinne to coordinate with Bluffs President regarding the review and decision timeline for the Boards to approve the JAC Seawall Contract.

New eligibility date for SHEHA members' participation in the Pontoon Lottery – the Board unanimously approved making the date stipulated in the SHEHA By-Laws for HOA eligibility (January 31<sup>st</sup>) the same date for determining Pontoon Drawing eligibility. "The Treasurer shall remind members of the By-Laws' January 31st deadline for consideration as a *member in good standing* at the annual HOA meeting, and that this same deadline determines SHEHA member

eligibility at the annual Pontoon Drawing." References to this decision will be included in Dues Reminder notices and in the JAC Pontoon Drawing Rules.

**Revised SHEHA 2019 Treasurer's Report** - The Board unanimously approved a Revised 2019 Treasurer's Report which will be posted to the website.

**SHEHA 2020 Budget** - The Board unanimously approved a 2020 Budget which will be posted to the website.

**SHEHA Dues Notification and Collection Process** – The deadline for 2019 Dues submission, June 1<sup>st</sup>, has passed. Larry reviewed the status of delinquent dues collections. The Board decided to pursue delinquent dues collections from 2017 through 2019, but to dismiss unpaid dues from 2016 and earlier due to the effort and expense involved in reconciling old bank statements with members' financial records. The Board unanimously approved a timeline and process which will be followed for the remainder of the SHEHA calendar year (May 31<sup>st</sup>, 2020).

**Combined Board meeting with the Bluffs and Estates Boards** – Corinne to finalize list of topics discussed at today's Board meeting and propose a combined Board meeting with the Bluffs President.

Subject: Process for SHEHA HOA 2019/20 Dues notification and collection

The Strawberry Hill Estates By-Laws stipulate that:

- An Annual Homeowners meeting shall be held during the month of April
- Notification of that meeting shall be mailed to members thirty days in advance of the meeting
- The annual deadline for members' dues payment shall be June 1st of each year
- Members who have not paid their dues by January 31<sup>st</sup> of the following year shall not be considered "members in good standing"

In concert with the timeline stipulated in those By-Laws, the Treasurer will schedule dues reminders at the following intervals:

- 1. **Initial notification** a preliminary dues remittal form will be included with the Annual Homeowners Meeting notice 30 days prior to the meeting
- 2. **1**<sup>st</sup> **notice** Will be mailed on May 15<sup>th</sup>, two weeks prior to the Dues Deadline of June 1<sup>st</sup>. The letter will be sent to members who did not pay via the preliminary remittal form or at the annual HOA meeting
- 3. 2<sup>nd</sup> notice Will be mailed on July 1<sup>st</sup>, one month after the Dues Deadline of June 1<sup>st</sup>
- 4. **Final Notice** Will be sent via registered mailed on December 1<sup>st</sup>, six months after the Dues Deadline of June 1<sup>st</sup> and two months prior to losing "member in good standing" privileges Members who have not returned dues payments by January 31<sup>st</sup> of the following year shall not be considered "members in good standing" at subsequent Association meetings or at the Pontoon Drawing.

The SHEHA Board shall decide upon taking additional measures to collect payments from members whose dues payments are delinquent for three consecutive years.
